### Background to the disclosures

The Public Services Reform (Scotland) Act 2010 ("the Act") received Royal Assent in April 2010. It contained a number of provisions for the restructuring of Public Sector organisations in Scotland and set up powers for Scottish Ministers to improve the exercise of public functions. It also imposed duties on Scottish Ministers and listed public bodies (including NHS Greater Glasgow & Clyde) to publish information on expenditure and other matters on an annual basis.

Under the Act's information provisions, NHS Greater Glasgow & Clyde must publish annually the following information:

### Section 31 disclosures

- Expenditure incurred in the financial year on public relations
- Expenditure incurred in the financial year on overseas travel
- Expenditure incurred in the year on hospitality and entertainment
- Expenditure incurred in the year on external consultancy (including that incurred on construction or infrastructure projects)
- Expenditure payments in excess of £25,000 not including remuneration
- The number of employees receiving remuneration in excess of £150,000



### Public Relations

The total expenditure on public relations for NHS Greater Glasgow & Clyde is £494,522 (2022/23: £409,167). This expenditure includes the running costs of the NHS Greater Glasgow & Clyde Communications department and associated support costs.



### Overseas Travel

The total expenditure for overseas travel for NHS Greater Glasgow & Clyde for financial year 2023/24 is £230,928 (2022/23: £261,687).

### Hospitality and Entertainment

This data incorporates all of the relevant cost off set recharges provided through catering services for meetings and events held internally within NHS Greater Glasgow & Clyde and the cost of Board meetings and away days. The total expenditure for NHS Greater Glasgow & Clyde for financial year 2023/24 is £89,866 (2022/23: £108,767)



### External Consultancy

There are two principal elements to this cost.

- **Revenue Consultancy:-** The total incurred for 2023/24 amounts to £2,123,730 (2022/23: £1,790,015).
- **Capital Schemes:-** The total incurred for 2023/24 amounts to £2,058,670 (2022/23: £859,718).

The total expenditure for consultancy costs for NHS Greater Glasgow & Clyde for financial year 2023/24 amounts to £4,182,400 (2022/23: £2,649,733).



### Expenditure > £25,000

### Employees in receipt of Remuneration > £150,000

In 2023/24, there were 721 people who received remuneration in excess of £150,000. 720 of these were clinical staff, and there was 1 non-clinical staff member who received remuneration in excess of £150,000.

The previous year (2022/23) there were 576 people who received remuneration in excess of £150,000. 576 were clinical staff, and there were 0 (2022/23: 0) non-clinical staff members who received remuneration in excess of £150,000.
