Virtual Person Centred Visiting

We know that colleagues have been using their initiative and have been appealing for iPads and mobile phones to let patients and family keep in touch during this time of very restricted visiting.

We are now launching a scheme as part of our Person Centred Visiting programme to increase virtual visiting through the purchase of 100 iPads, complete with FaceTime, Skype and Zoom.

The iPads will be distributed to all acute and mental health hospitals this week.

This development means there is now no need for staff to make any more public appeals for devices.

Research and Development update

R&D have set-up a COVID-19 Taskforce Group chaired by R&D Director Julie Brittenden. We currently have clinical trials and research data collaborations underway.

The aim is to ensure that NHSGGC patients and clinicians have:

- access to the best possible experimental treatments and that this will lead to improved knowledge and availability of drugs that are proven to work to the wider population
- 2) increase our understanding of COVID-19 to help improve patient care and public health policy
- 3) increase knowledge of the genetic "make up" of the virus, so we can get better ways to detect, prevent and treat COVID-19.

Car parking

We have made it easier to park on our sites by temporarily relaxing parking restrictions. Unfortunately due to the lifting of restrictions, drivers are parking in areas which need to be kept clear for essential deliveries.

This is causing problems with critical supplies including oxygen. If this continues it may be necessary to reintroduce monitored parking including having cars towed away if they are inappropriately parked. Please help us ensure that essential supplies are getting into our hospitals by parking sensibly.
