# DAILY REMINDER: Don't Spread the Virus at Work or Home

#### Health & Safety Forum

The NHSGGC Health and Safety Forum was held recently, with representation from across GGC. A number of topics, relevant to YOUR Health and Safety were discussed, with some key highlights for note being:

## Social Distancing and Risk Assessment

The forum reviewed progress against the implementation of the Guidance on Social Distancing document, and resultant risk assessment process across GG&C. It was recognised that a significant volume of work had been completed, with over 1200 risk assessments generated, and roll-out of identified control measures.

Risk assessments should be reviewed, if:

- Staff numbers within the area increase.
- Any changes take place that could impact the suitability of the control measures.
- Opportunities for improvement in control measures are identified by staff.

#### A support document is available.

Please ensure you have visibility of the risk assessment for your area of work and are aware of the control measures in place to protect you, your colleagues, patients and visitors.

All staff are required to comply with the risk assessment for your area of work.

#### **Personal Protective Equipment (PPE)**

The Forum noted the current position in relation to PPE.

Information to support the safe use of face masks is available as follows:

- Users of face masks should ensure they undertake a pre-user check, see our <u>Pre-user Checklist</u>.
- For information on correct use of PPE, including how to dispose of it safely, see our <u>PPE Donning &</u> <u>Doffing Poster</u>.

## **H&S Training**

There was a particular focus in relation to sharps and falls training, and moving and handling competency assessments. It is important that all GGC employees complete the health and safety training that is required of their role.
