Message from Jane Grant, Chief Executive (12 April 2024, 2.50pm)

This week, the Royal Alexandra Hospital received a three-day unannounced safety inspection from Healthcare Improvement Scotland (HIS). In addition, HIS inspectors spent a day each at the Emergency Departments at QEUH and the GRI. This was the first occasion when inspectors visited multiple sites on the same week and I know that this required a significant response from many teams and staff members. My sincere thanks go to staff from all areas inspected for accommodating HIS and for your professionalism and support to the inspection team.

As part of our sustainability strategy, staff should be aware that as of the 22nd of April, across NHSGGC a charge will be implemented for the use of electric vehicle (EV) charging points.
