### Second-hand smoke and smokefree legislation

The Quit Your Way team have launched a new campaign featuring respiratory physician <u>Dr Joris Van der Horst</u> which highlights the effects of second-hand smoke and the importance of not smoking on hospital sites.

As communicated in previous Core Briefs, last September the Scottish Government introduced new legislation making it an offence for anyone to smoke within 15 metres of an NHS hospital building. By creating this boundary, the aim is to reduce exposure to second hand smoke for all of our patients, staff and visitors, particularly for those who are at high risk.



If you smoke, the best thing you can do for yourself and others is to stop. Quit Your Way is a free NHS stop smoking service available to everyone who wants to stop smoking. Red4Research day is an opportunity to celebrate those participating in, undertaking and supporting clinical research.

The Paediatric Clinical Research Facility (CRF) works closely with the Royal Hospital for Children to support access to cutting-edge research for children and families receiving care at the hospital. We support approximately 50 studies taking place across the children's hospital and with over 700 children currently involved in active studies, our work includes trials of new medicines, trials to provide evidence for the use of current medicines and to determine best clinical practice.

To raise awareness of the important contribution our patients and staff make to clinical research, the paediatric CRF will be holding a stall in the foyer of the Royal Hospital for Children on Wednesday 14 June. Come along to find out more about what we do and how your department can get involved!

# Changes to fire response from 1 July affecting NHSGCC Community and Hospital buildings

From 1 July 2023, changes within Scottish Fire & Rescue Service (SFRS) policy means that they will no longer automatically attend all fire calls that have originated from the buildings' fire detection system.

#### Who will be affected by the change?

Many community buildings and possibly some non-sleeping hospital site buildings will be affected. The change excludes any building that is part of a sleeping risk, therefore all inpatient areas and attached buildings will still receive a SFRS attendance if the fire alarm activates.

NHSGCC has formed a Short Life Working Group to assess and adjust to any required changes to affected buildings and, where required, will assist local managers to introduce any adjustments to the present procedure.

It is critical that staff continue to place a backup call for all fire alarm activations, as reinforced during your annual fire training.
