Learning from Significant Case Review: Learning & Education Training Sessions 2022

A Significant Case Review (SCR) or Learning Review is a multi-agency process for reviewing a situation where an adult or child has died or come to harm within an adult or child protection context, in order that we learn lessons about how to better protect those who may be at risk in our community.



This learning session will focus on the case of Child D who had complex health needs and was known to a number of services including acute, SCS and community.

SCRs are a critical part of the continuous improvement of practice and processes and it is important that all NHSGGC staff have the opportunity to reflect and learn from such cases.

National Rail Strike - Plan ahead to avoid disruption

Network Rail have announced there will be industrial action on the 18th and 20th August. This will cover all of the UK rail network and will result in the majority of rail services, including ScotRail services, being cancelled on these days. In addition, there is likely to be a residual impact on the days following the industrial action as Network Rail staff return to work and carry out safety critical checks.
