### Using Wardview to improve patient care: Training and fault reporting

WardView is a ward/bed management application accessed on the wall-mounted touchscreens located on most NHSGGC wards. The app is integrated with TrakCare and Clinical Portal and provides real-time ward information helping us facilitate more efficient bed transfers and changes to estimated discharge dates (EDDs).

The resource is crucial in allowing us to manage discharges and admissions to ensure a smooth flow of patients into and out of our wards and to help ensure that we're utilising bed capacity as effectively as possible. We would like to remind all relevant staff to ensure they're familiar with the resource and inputting as appropriate.
