# Highlight report from the Urgent and Unscheduled Care Oversight Board

The Oversight Board, which includes acute and HSCP representation, with planning, eHealth and communications colleagues, continues to meet monthly to progress changes and improvements to urgent and unscheduled care across NHSGGC.

The latest meeting of the Programme Board took place on Friday 23 June. Key highlights reported at the meeting included:

### New patient pathways

The Outpatient Parenteral Antibiotic Therapy (OPAT) service is currently running at the highest efficiency with more people in, more people out and more early supported discharge. OPAT is fully up and running in QEUH, IRH and RAH.

The Flow Navigation Centre (FNC) continues to see high volumes of activity and sustained high closure rates, with more than 44% of patients being discharged entirely remotely.



Close working with the Patient Experience Public Involvement team to launch an automated patient experience survey following each video consultation has collected 1555 responses (increased from 1072 from the previous month) since going live on 16 February.

# **Discharge without Delay**

We have completed the rollout of the Discharge without Delay Bundle (DwD) including gap analysis which aligns to the self-assessment in 130 acute adult wards (DME, Medical, Surgical and Orthopaedics). This was accelerated and complete by the end of June 2023, brought forward from September.

Mental Health have not yet begun the DwD Bundle roll out this will be planned as part of the work plan of the group. The next phases include the remaining acute wards as well as MH.

### **Urgent Care Medical Pathways Steering Group**

Items discussed at the Urgent Care Medical Pathways Steering Group included:

- Call Before Convey: Call Before you Convey Transition of Care (ToR) took place on Wednesday 14<sup>th</sup> June – Friday 16<sup>th</sup> June. The ToC is currently being written up and outcomes will be shared via the redirection/signposting group and Acute/SAS Directors.
- **Care home falls pathway:** A meeting arranged for week beginning 3rd July following discussion at last Virtual Pathway meeting.
- **GP OOHs interface:** A two way referral process between GP OOHs and FNC is being explored to establish a route of direct access for both services.

### NHS Scotland Event 2023 resources

This year's Event took place on Monday 19 June at the SEC in Glasgow.
