Are You Ready?

As you will be aware on the 1 July Scottish Fire & Rescue Service (SFRS) will no longer attend automatic fire alarm activation in **non-sleeping** buildings, unless there is a confirmed fire, or signs of fire. This will affect many community buildings, onsite buildings and "offsite" staff only buildings. The NHSGGC Fire Officer Team have been working with managers for many months now, and all affected buildings should have a programme in place in order to be ready for the changes on 1 July 2023.

So, the question is "Are you Ready?"

This process requires trained staff to be able to silence the fire alarm system, investigate the cause of the activation, (<u>See Investigation Document</u>), and reset the fire panel prior to reoccupy the building.

Will you be ready? Do you need additional assistance? Is your programme in place?

Remember business continuity and service delivery will rely on building management having a robust procedure and trained staff in place to reoccupy the building after an evacuation. SFRS will not be present. It is the management's responsibility for ensuring the required procedures are conducted within their affected buildings, the Fire Team are there to support and assist. There will be no increase with regards the timeline, these changes take effective as of 1 July 2023.

Research study on mental ill-health and hospital acute care for heart attack

People with severe mental illness (SMI), including schizophrenia, bipolar disorder and major depression, die sooner than the general population, largely due to a greater burden of cardiovascular disease. This vulnerable group have poorer outcomes, in terms of survival and further vascular events, following a heart attack than people who do not suffer from such conditions. Reasons are poorly understood and likely multifactorial, but differences in access to or receipt of care may play a role.

We are recruiting 15-20 healthcare professionals (HCPs) involved in delivering hospital clinical acute care for people with a heart attack in the Central Scotland area, including NHSGGC. We are looking for HCPs with some experience of delivering hospital acute cardiac care to people with mental illness.

If you take part, a researcher will conduct a short (up to 45 mins) qualitative interview with you by video /phone call and a small thank you of a £10 voucher will be given to each interviewee. This study will provide insights into HCPs' experiences of delivering care to this vulnerable population group, identify any challenges/barriers and inform approaches to supporting delivery of the best possible care.
