Ukrainian Temporary Residents – Additional guidance for recording within Patient Management Systems

The Overseas Visitors Process (OSV) is initiated for all patients who attend NHSGGC hospital, primary care and community sites

On arrival, patients are asked if they have been resident in the UK for the last 12 months and if patients advise that they have not, an OSV interview is undertaken to establish their status and whether they are eligible to pay for treatment etc. While payment is not the issue in these circumstances, this process will identify patients from Ukraine who are temporary residents as a result of the current conflict.

To ensure correct recording for Ukrainian residents across all of the key Patient Management Systems and to allow easy identification and subsequent reporting, additional guidance documents have been created.
