MFA is a two-step log-in process that requires staff to enter more information than just a password. Setting your MFA enhances security, protects against unauthorised access and ensures the integrity of our data. All staff must ensure they have MFA configured. Whooping Cough (Pertussis) Vaccine

Staff drop-in clinics this week

If you're in one of the following NHSGGC staff groups, you are urged to get your whooping cough (pertussis) vaccination at our drop-in sites in the coming weeks. This is to protect you and to avoid transmission to patients. No booking is necessary.

Priority vaccination groups:

- 1. Healthcare workers with regular/close clinical contact with severely ill infants (under 3 months old) and women in last month of pregnancy, including maternity, obstetrics, neonatal and paediatric intensive care
- 2. Healthcare workers with regular clinical contact with young unimmunised infants in hospital or community settings, such as other paediatric services and health visitors
- 3. Healthcare workers with intermittent clinical contact with young unimmunised infants in the community, including general practice.

Please note questions will be asked by immunisation nurses to ensure you meet criteria prior to receiving the vaccine. Clinics will be at acute sites and community-based settings. Staff can attend any clinic regardless of their work-base location. Dates and locations will be shared in Core Brief and Staffnet.

The measles, mumps, and rubella (MMR) vaccination will also be available at the clinics, to staff who have no history of MMR vaccination or are unsure regarding their vaccination status.

It is anticipated that uptake for vaccination will be high and we ask you to understand that some clinics may be busier than others throughout the sessions. If for any reason you are not able to access the vaccination at a scheduled drop in clinic, please contact the Occupational Health Service to arrange an appointment at the WGACH Hub by emailing <u>occupational.health@ggc.scot.nhs.uk</u>.

As doctors at NHSGGC, fostering a safe and inclusive environment for our entire staff is key. This is why we are so supportive of our new programme, "Cut It Out", which tackles the serious issue of sexual harassment in the workplace and makes it explicitly clear such behaviours will not be tolerated in NHSGGC.

Sexual harassment can take many forms, from unwelcome jokes and comments to unwanted physical

Revised Peripheral Venous Catheter (PVC) Care Plan

A revised PVC Care Plan is due to be launched in the coming weeks within all adult and paediatric hospitals.

Remember to run down stock of the current PVC Care Plan and if you need additional stock, where possible, borrow from other wards who may have excess.

The changeover from the old PVC Care Plan to the new one will be **00.01am on Monday 15 July 2024**. The new PVC Care Plan can be ordered using the Medical Illustrations code **MIS 348776 v2.0** and can order these from 1 July onwards.

The main changes to the new care plan are as follows

• PVCs should be removed when no longer required with a max dwell time of seven days New layout for day and nightshift twice daily reviews

 QR code quick links for Adult & Paediatric IV Oral Switch Therapy (IVOST) guidelines

Roadworks - QEUH

The next phase of the Scottish Power works adjacent to the QEUH campus will result in the <u>full</u> closure of the Moss Road/Govan Road junction from 9.00am on Thursday 4 July 2024 for an estimated five days. A local diversion will be in place, however significant disruption can be expected – especially at peak times – for patients, visitors and staff.

Access to and from the Campus will continue to be available via Hardgate Road, but these junctions are also likely to be much busier than normal throughout the duration of the work. Please consider alternative routes where appropriate and allow extra time for your journey to and from the QEUH campus.
