Data Security Spotlight – Password security

Strong passwords and password security are essential to protect the integrity of our systems and our data. Always follow our guidance <u>here</u> on creating strong passwords and never share your password with anyone else.

Hate Incidents - Support to report in NHSGGC

Something is considered to be a hate incident if the victim or anyone else think the incident was motivated by hostility or prejudice based on one (or more) of the victim's characteristics of disability, race, religion, transgender identity, sexual orientation, age or variations in sex characteristics.

All hate incidents should be recorded on the DATIX incident recording system <u>Datix</u> <u>Homepage (scot.nhs.uk)</u> and, where appropriate, also reported to Police Scotland. No member of staff should be expected to accept behaviours in the workplace that would be unacceptable in our private lives.

Left unchecked and unchallenged, hate incidents undermine our efforts to build a respectful, inclusive and cohesive working environment. We can all make a difference by taking a stand against hate. For more information visit our Hate Crime information page: <u>Hate Crime - NHSGGC</u>.
