Safeguarding - It Matters to Us: NHSGGC Public Protection Strategy 2023 – 2026

In marking National Adult Support and Protection (ASP) Awareness Day we are delighted to launch '[Safeguarding - It Matters to Us – NHSGGC Public Protection Strategy 2023 – 2026](#)'.

The strategy sets out our approach to safeguarding and protecting people. Our staff continue to be at the forefront of preventing and identifying people at risk of harm. Our principles and six strategic aims are clear- safeguarding and the protection of people in NHSGGC is “everyone’s business, everyone’s concern and everyone’s responsibility”.



Current key developments in relation to ASP include:

- Establishment of an NHSGGC Adult Support and Protection Forum to provide oversight in relation to ASP.
- NHSGGC ASP guidance and revised wall charts will be available soon detailing the AP1 Referral Process.
