# **Fire Safety Training**

Fire safety is everyone's business. Whether you work on a ward or in an office we all need to know what to do in the occurrence of fire.

Fire can happen anywhere and at any time and it is vital that all NHSGGC staff complete their Fire Safety Training via LearnPro annually. The module can be found on LearnPro, Course Code: GGC001 Fire Safety Training.

If you don't have a LearnPro account please contact LE Support on 0141 278 2700, option 3 and have your NHSGGC payroll number handy. This will used as your personal identifier so that your completed learning can be accurately recorded. You can also speak to your line manager as face to face General Awareness Fire Training sessions are being run across all Board sites.

Ward Managers are also reminded that in addition to the LearnPro module ward based staff should also be provided with ward based fire safety orientation training annually as per the fire safety policy.

#### National Uniforms – Changes to pack sizes. Garments affected – tunics, polos and cargo trousers

NHSGGC's National uniform provider Dimensions is making some changes to how it delivers items to help reduce plastic packaging and become more sustainable. By moving from single packs to twin packs of tunics, polos and cargo trousers, there will be a 50% reduction in plastic waste which will also reduce waste for NHSGGC.

As part of this move, we have been informed there may be some short term challenges during the transition as single stocks are run down and twin packs arrive. Dimensions will be in contact to ask that POs are amended to reflect the new style codes and pricing is updated to reflect this change. As we are in the process of running down single garment packs POs will see a mixture of both single and double packs arriving during this process. Any current back orders will be substituted to the new product code and Dimensions will notify the health board of any amends required.
