### **Hand Hygiene**

The Infection Prevention and Control Teams are seeing an increase in staff across all disciplines wearing nail polish, including gels and acrylic nails and wrist worn technology devices.

The National Infection Prevention and Control Manual and the NHSGGC Hand Hygiene Guidance both state that prior to performing hand hygiene staff should:

- Be bare below the elbows expose forearms remove outerwear, roll up sleeves;
- Remove all hand/wrist jewellery, including wristwatches and wearable fitness devices (a single, plain metal finger ring is permitted but should be removed (or moved up) during hand hygiene);
- Bracelets or bangles such as the Kara which are worn for religious reasons should be able to be pushed higher up the arm and secured in place;
- Ensure fingernails are clean, short and that artificial nails or nail products are not worn e.g. polish, gel, shellac, etc.
- Cover all cuts or abrasions with a waterproof dressing.

# Flying Start Portal – Support Sessions – NEW DATES

Flying Start NHS® is the national development programme that the Scottish Government and NHSGGC requires all registered nurses, midwives and allied health professionals (AHPs) to complete, in their first year in practice. Each newly qualified practitioner (NQP) within NHSGGC, should be afforded 24 hours protected learning time away from the workplace to support completion of the Flying Start NHS® programme within the first year.

To support all NQPs, whether you are just commencing the programme, are working towards or nearing completion of this, the Practice Education team will be hosting further Flying Start Support Sessions on MS Teams. These sessions provide peer support and discussion and highlight other relevant information, which you will find helpful to clarify Flying Start NHS® programme requirements.
