Addition to Ward iPads

As part of the "What Matters to You" day 2022, the Infection Prevention and Control (IPC) Team spoke to patients and their relatives to gather feedback on what matters to them when being cared for in an isolation room. One of the main points raised by several patients and relatives was the lack of Patient Information Leaflets

(PILs) provided to them when in isolation. To help address this, all the PILs are now available for staff and patients to access via the ward iPads. These can be accessed by using the IPC icon on the home screen which links directly to the PILs on the IPC intranet page (icon opposite). Staff can increase font size and brightness to suit the patients' needs. This will also help with sustainability.

Some of the PILs are available in other languages but if there is a specific language that would suit your patients or if there are any PILs that are not available that you think would be beneficial to your patient group, please do not hesitate to contact your local IPC Team.
