Carers Rights Day and National Carers Awareness campaign

Today is "Carers Rights Day" which coincides with the launch a new national campaign from Scottish Government to raise awareness of unpaid carers. Since the pandemic began it is thought that an additional 392,000 people have taken on a caring role, bringing the total number of unpaid carers in Scotland to around 1.1 million - that is almost 1 in 5.

We are proud to support this campaign, encouraging everyone to read between the lines to see the impact caring can have on people.

Without help and support, carers can become isolated, stressed and exhausted which may lead to a crisis point and deterioration of relationships. This is why early intervention and support is crucial. However, we also understand that every carer is unique, which is why support is tailored to suit everyone's individual need.

Please help us to spread the word and encourage carers to seek support. NHSGGC is a Carer Positive organisation, meaning that we have policies in place to support carers within our workforce. You can visit <u>HR Connect</u> pages to find out more information.

As staff we also have a responsibility to ensure carers are identified, involved and supported. This includes a **legal obligation** to involve carers in discharge planning. Staff can refer carers to their local support services by calling 0141 353 6504 and giving details of the carer's name, postcode and contact number.
