New Home Energy Crisis Response Service

NHSGGC has launched a Home Energy Crisis Response Service for patients in Acute and mental health care.

Delivered by Money Matters, the new service will target patients who need help with home energy in order to return home safely from a hospital stay without the worry of the additional health consequences of living in a cold, damp home.

Utilising a combination of onsite hospital engagement and remote assistance, the service will tackle energy emergencies, advocate on behalf of patients with energy providers and help with access to external home energy emergency funds.

A person is eligible if they:

- · are a patient or carer accessing or receiving care from an NHSGCC hospital
- have any immediate or emergency need relating to meeting home energy costs
- are experiencing poverty/financial difficulties.

Referrals to the Home Energy Crisis Response Service can be made by contacting NHSGGC's Support & Information Service and Family Support & Information Service.

As part of this service, a Home Energy adviser is based at various hospital sites throughout the week, however the service is available Monday–Friday across all NHSGGC hospitals.
