Suicide Risk and Design Standards Group Update

Phase one of the en-suite door replacement work within mental health services has, to date, removed and replaced 188 en-suite doors. The doors now in place are the Safehinge Primera, which removes the most common potential ligature point and improves observation into the en-suite.

Phase two of the en-suite door upgrades is due to commence in November 2023. The door being installed in phase two has an increased magnetic strength of 6kg and will cover the following areas:

- Langhill Clinic, IPCU and the Acute Assessment Unit
- Eriskay House
- Kershaw Unit

NHSGGC and Safehinge Primera are working together to adapt the current reduced ligature door for use in older peoples care, continuing care and the learning disabilities service. The aim is to have a trial in a clinical environment in November this year with a suitable door to be available in 2024.

Transport update

Great Scottish Run – 1 October 2023

The Great Scottish Run will take place on Sunday 1 October and will result in local road closures and diversions across Glasgow City Centre and surrounding areas, including slip road closures for M8 and M77 access. For more information, please visit [Glasgow City Council](#) website.

Battlefield Road Closure

From Monday 9 October 2023 until Friday 24 November 2023, Battlefield Road will be closed to traffic between Overdale Avenue and Overdale Gardens. This is to allow Scottish Water to carry out essential repairs on defective drainage from the existing footpath to the main sewer. A diversion has been agreed with Glasgow City Council along Grange Road and Langside Road. Pavements will remain open to pedestrians and for access to local businesses, but this could cause delay for travel to and from the New Victoria Hospital.
