Data Security Spotlight – Supplier Email Compromise

Supplier Email Compromises have become much more common in recent times, this in turn can lead to malicious emails coming into NHSGGC from these organisations. Should you be informed of any ongoing Cyber Incidents occurring with your suppliers, including any correspondences where they may advise they have resolved the issue, please raise an urgent incident through ServiceNow.

Appointment of the Interim Deputy Medical Director – Mental Health and Addiction Services

Healthcare Improvement Scotland inspections

Healthcare Improvement Scotland today (Monday 8 July) published inspection reports relating to safe delivery of care inspections in NHS Greater Glasgow and Clyde.

During week commencing 8 April 2024 they inspected three hospitals in NHS Greater Glasgow and Clyde using their safe delivery of care acute hospital inspection methodology: the Emergency Departments at the Queen Elizabeth University Hospital and Glasgow Royal Infirmary, and a hospital wide inspection of the Royal Alexandra Hospital. The inspections were undertaken to provide assurance to the public regarding the quality of care being provided at these hospitals and identify where any immediate improvements needed to be made.

Donna Maclean, Chief Inspector, Healthcare Improvement Scotland, said:

"We found the Emergency Department of Queen Elizabeth University Hospital was calm and well-led on the day of inspection. Staff described a number of initiatives to improve patient experience within the department. We observed staff working hard to provide compassionate responsive care. Areas for improvement have been identified, including hand hygiene compliance, the management of used linen and the safe storage of cleaning products.

"Our hospital-wide inspection of Royal Alexandra Hospital observed teams delivering safe and effective care in calm and well-led areas. Hospital safety huddles demonstrated open communication and we observed senior staff working collaboratively to mitigate risks. Patients were complimentary on the care they had received, and staff described the hospital as a good place to work. Areas for improvement have been identified, including access to adequate cleaning materials and the establishment of assurance systems for cleaning and safe storage of medication."

Following issues being raised by HIS at the time of the GRI inspection in April, a number of actions and improvements immediately took place assuring safe, quality care is in place.

A second visit was undertaken by HIS in early June and we look forward to receiving their report.
