**Michelle Wailes** is a Fellow of the Institute of Chartered Accountants in England and Wales with over 18 years' experience in the professional and financial services industries and the public sector. She started her career with PricewaterhouseCoopers, working in the Government and Public Sector team. During this time she was engaged on the delivery of statutory audit services, internal audit services and specialist advisory projects across a wide range of Public Sector Bodies in Scotland and the South East of England. She then spent 10 years working at the Clydesdale and Yorkshire Bank Group where she gained extensive experience in internal audit, risk and corporate governance. Michelle is currently a Board Member and Chair of the Audit and Risk Committee at Scottish Canals, and from 1 April will also take up a role as a member of the Police Investigations and Review Commissioner Audit and Accountability Committee.

**Paul Ryan** qualified in Medicine in 1979, and after a few hospital posts joined a general practice in North East Glasgow in 1983, where he continues to work. He was also a Clinical Director in Primary Care in the Health Board for 11 years.
