What Matters to You Day 2021

Today is 'What Matters to You?' (WMTY) Day, all about celebrating and encouraging meaningful conversations between the staff who provide care and the people who receive it.

The WMTY approach builds on the principles of person centred care by asking, listening and doing what matters. Flipping the question from 'what's the matter?' to 'what matters to you?' is about changing perspectives, expectations and creating a meaningful collaboration between people providing care and people requiring it.

Today, we are encouraging everyone to have a meaningful conversation with the people they care for, their families, and colleagues, about what matters most to them.

Return to standard car parking arrangements

Following Glasgow City Council area's move into Level Two restrictions from Saturday 5 June, increased patient and visitor activity on all hospital sites, and more frequent public transport services, we now advise staff that managed car parking services will be reinstated on **Monday 28 June 2021.**

From that date, controlled parking arrangements will resume and staff should park only in designated staff parking bays as appropriate. This means that staff permit holders should park only in the designated permit spaces. Staff without valid parking permits should park only in spaces designated for non-permit staff. On no account should staff park in spaces that are designated for patients and visitors between **07:30 and 16:30**

Staff: For information, statutory/mandatory training modules on Learnpro can be accessed up to 3 months prior to your expiry date and will therefore enable you to remain compliant.

Managers: Managers are encouraged to review the HR Notification issued by email on a monthly basis as this highlights those staff members who are non-compliant (Red), or due to re-take modules up to 3 months ahead of the renewal date (Amber).

Please monitor your staff to ensure they remain compliant with their statutory mandatory training requirements.
