In today's Life on the Frontline video we meet <u>Jac Ross</u> who leads the Equality and Human Rights Team.

Jac explains how the focus of her team has been ensuring that our COVID response included those who may be differentially affected or who required additional support to access information, support or services. An example of this is their work to target and support our Black and Minority Ethnic Communities. Early in the pandemic it became apparent that the BME communities were disproportionately affected by COVID, so the team made it a key area of focus

Updates to Care Homes and Community Health & Care COVID-19 & Acute setting Addendum

The key updates in the Addendum are as follows:

Care Homes & Community Health & Care settings

Updated to reflect key change in controls for decontamination of care equipment and environment from TBPs to SICPs within the Medium Risk category.

Care Homes and Acute setting COVID-19 Addendum

Updated advice and guidance on requirements for self-isolation and testing following discharge from hospital to care homes (for COVID recovered and non COVID). This is to reflect recent change in the guidance from PHS COVID-19 Information & Guidance for Care Home Settings (Adults & Older People) published 24/06/2021.

You may be a member of the NHS Superannuation Scheme approaching a point in your career where you are unsure of the financial options available to you regarding the continuation of work or making a decision to retire.

You can receive personal information relating to your particular pension scheme decisions, by contacting the NHS Staff Benefits Team using the confidential enquiry form here: Contact NHS Staff Benefits.

The contact form will ask you some questions about your working life in NHSGGC to date. This is to help the NHS Staff Benefits Team respond to your query with appropriate information. Follow up contact will be made to you by telephone from the NHS Staff Benefits Team.
