Person Centred Virtual Visiting update

As Person Centred Visiting is being remobilised across NHSGGC, it is important to remember that Person Centred Virtual Visiting (PCVV) remains a vital tool to support person centred care in hospital.

Even as visiting restrictions are lifted, there are still many people who are not able to visit patients in hospital. This may be due to temporary visiting restrictions being in place, clinical considerations or simply people live a distance away. Therefore it remains important to support conversations between patients and the people who matter to them.

This update therefore provides important reminders about PCVV, namely:

- The process to be followed for discussing and offering PCVV
- Data security when using the PCVV iPads
- Availability of information in other languages.

The process to be followed for discussing and offering PCVV

PCVV should be routinely offered as part of a discussion with patients and their families when they are admitted to each ward and throughout their hospital stay.

It is important to find out who matters most to each patient, and how they would like to stay in touch with them, either in person or virtually.

The outcomes of this discussion should be recorded in the My Admission Record or equivalent documentation, to enable this information to be available to the multidisciplinary team.

Data security when using the PCVV iPads

Relative contact details must be deleted from the PCVV iPads immediately after a Virtual Visit. Not to do so would be regarded as a breach of the Data Protection Act, and risks these details being inappropriately used to call relatives in error after a patient has been discharged.

Availability of information in other languages

Interpreters should be used to support a discussion with patients about who matters to them, and how they would like to stay in touch while in hospital, when patients do not have English as a first language.

The PCVV iPads can be used to access this interpreting support, or telephone interpreting is still available.

Information for patients in alternative languages is also now available on the home screen of every PCVV iPad. Look for the icon titled 'BSL & Other Languages' circled in red in the picture right. It is also available on the <u>NHSGGC website</u>.
