#### Keep medicines secure at all times

Medicines are a critical part of our work and they are essential for healthcare; however, in the wrong hands they can pose serious risks. Medication misappropriation refers to the unauthorised use, theft, or diversion of medicines from clinical environments. **Theft of medicines is a criminal offence.** 

There are a number of actions in place to allow immediate identification of any stock imbalances:

- Audit
- Dashboards
- Stock balance checks

Additionally, a process mapping exercise has been conducted to enhance the efficiency and security of the medicine supply chain, from the point of ordering to administration. This will further tighten security measures. We would remind all our staff – even if they are not directly involved in ordering or administering medicines - to familiarise themselves with local medicine security guidance, and to follow two simple rules to help us secure our medicines supplies:

- **Be vigilant** notice something unusual or unsafe? Speak up immediately!
- **Be secure** keep medicines under lock and key in designated storage e.g. ward medicine cupboards.

Please refer to the Safe and Secure Handling of Medicines (SSHM) Policy available on the NHS GGC Prescribing Website <u>SSHM Policy</u> for all details on the practical arrangements in relation to medicines handling (including procurement; ordering; storage; transport; administration; supply and disposal).

# **Radiation Safety**

The Department of Clinical Physics and Bioengineering (DCPB) team is critical to ensure the radiation safety of staff, patients and members of the public. Our work covers:

- patient diagnostic tests using X-rays, CT, MRI and radioactive materials
- patient therapies, such as UV phototherapy, radiotherapy and radionuclide therapies

- the safety of staff working with these radiations, and the safety of staff and members of the public who are present in areas close to where the radiation is in use.
- the environment that may be exposed to radiation following disposal of radioactive materials.

Several specialisms within DCPB have the responsibility to oversee, assess and improve compliance with the relevant radiation safety legislations. Health Physics, who provide the Diagnostic Radiology Physics and Radiation Protection service, Nuclear Medicine (for administration of radioactive materials to patients for diagnosis and therapy), MRI Physics and Radiotherapy Physics are all responsible for their specific area of expertise.

All staff working with radiation should be aware of their own responsibilities under the legislation, such as:

- protect yourself and others from any radiation hazard arising from their work
- · read and agree to act in accordance with the departmental Local Rules
- ensure any dosemeters issued to you are worn as instructed and returned promptly
- wear the PPE that has been recommended and provided.
