# **Social Distancing Update**

Scottish Government guidance related to physical distancing within healthcare settings has been updated.

This guidance identifies areas with healthcare settings that <u>could</u> reduce to one metre physical distancing, provided the wider hierarchy of controls are in place.

NHSGGC has sought the views of staff and staff representatives, with key issues considered on how the new national guidance can be applied in a way that is protective of staff and easy to understand while recognising the current levels of COVID within our communities. Therefore the Strategic Executive Group have agreed today that NHSGGC will adopt the new guidance as follows:

- Two metre physical distancing remains in place across GGC in all inpatient wards
- Two metre physical distancing remains in place across GGC in all common areas such as foyers, circulation areas, canteens, changing areas etc
- For other areas that fall within the scope of the new guidance, and identify the <u>need</u> to reduce physical distancing, a robust risk assessment must be carried out to determine feasibility.

Guidance and associated documentation that is in place to support physical distancing will be updated to reflect these changes and communicated in due course. This includes an **updated risk assessment template and an addendum** that highlights the areas that fall within the scope of the new guidance. The outcome of this risk assessment must be recorded, retained and communicated locally. The risk assessment process should be carried out in partnership with staff.

Please continue to maintain current control measures. In particular, we would remind you that staff in non-clinical, non-public areas and offices <u>must</u> wear a face covering as a minimum or a Fluid Resistant Surgical Mask (FRSM-TYPE IIR) where two metre social distancing cannot be achieved and when in common areas like stairwells, reception areas and corridors. Face coverings must not be worn in clinical areas where Fluid Resistant Surgical Masks (FRSM-TYPE IIR) are required as a minimum.
