| Statement | All HCW must adhere to policy for decontamination of DWL and BWDS. | |
| Requirements | Dental Nurse Team Leaders should ensure staff have the necessary equipment available. A room with a designated clinical wash hand basin for hand hygiene only and a sink for any other purposes. HCW are trained in the procedure. Personal protective equipment (PPE) (visor, apron and gloves). Manufacturer's guidelines must always be followed when preparing approved DWL disinfection product. | |
| Procedure | Prior to every clinical session HCW to flush each individual water line for one minute using the following steps: Ensure all power source to Dental Chair is switched off. Hand hygiene is carried out. Personal protective equipment (PPE) must be worn (visor, apron and gloves). Inspect dental unit water bottle for any obvious contamination. Disposing and replacing any contaminated bottles in the clinical waste stream. Ensure manufacturer's recommended water decontamination product is added to bottle (e.g. ICX tablets). Fill bottle from cold-water tap. Attach water bottle to dental unit and switch on power supply to dental chair. Flush each individual water line for one minute. Remove PPE and carry out hand hygiene using approved alcohol hand gel or liquid soap and water. Complete GDH SOP Cleaning of Near Patient Healthcare Equipment checklist. Dental operator will flush each dental hand piece for a minimum of fifteen seconds after each patient. | |

Hand hygiene must be carried out using approved alcohol hand gel or liquid soap and water. PPE must be worn (visor, apron and gloves). Remove water bottle and empty contents down the designated nonhand hygiene sink. Inspect dental unit water bottle for any obvious contamination. Disposing and replacing any contaminated bottles in the clinical waste stream. Bottle must be inverted to facilitate drying and stored on a clean work surface. |
| | Remove PPE and carry out hand hygiene using approved alcohol hand gel or liquid soap and water. Complete GDH SOP Cleaning of Near Patient Healthcare Equipment checklist If there is any reason why this procedure cannot be completed report to Dental Nurse Team Leader. |
| After care | Ensure manufacturer's recommended water decontamination product is stored appropriately according to NHS GG&C COSHH Policy. |
