1. Objective

To ensure process for all radiology examinations and procedures to have documented results.

Radiology auto reports - a clinical evaluation is required within the patient notes, which is a delegated operator requirement of the entitled referrer.

Radiology formal reports required for all other examinations/procedures.

2. Practical Procedure

Clinical services

There is an agreed delegation through IR(ME)R for all referrers to interpret and documents the clinical evaluation. There is an ongoing requirement for the services to undertake regular audit of this to ensure adherence.

Radiology service

Any clinical evaluation carried out by an entitled Operator on CRIS will be checked and verified before it is sent to the referrer.

The radiology department will issue at the time of the exam/procedure acquisition an auto report.

Clerical staff on a regular basis will produce a statistical report highlighting which examinations have not been reported and ensure that this is made available to an entitled Operator for reporting.

Should the entitled Operator feel that any images within scope for an auto report merit a formal report then they should make a comment in the reasons for examination box to indicate to the reporter the reason for not providing an auto-report.
