TERMS AND CONDITIONS FOR NORTH LANARKSHIRE LEISURE MEMBERSHIPS

As part of its staff policy on promoting physical activity NHS Greater Glasgow & Clyde offers employees interest free loans to assist them in purchasing North Lanarkshire Leisure NHS corporate membership. The following rules apply to the scheme.
