#### Remit of the Review

This is the first of a series of bulletins about the Queen Elizabeth University Hospital Independent Review ("the Review"), focussing on infection prevention and control in the newly-built hospital complex.

The Cabinet Secretary for Health and Sport announced the Review in January this year to address concerns about patient safety, and

specifically to look at the buildings' "design, commissioning and construction, handover and ongoing maintenance and how these matters contribute to effective infection control." Our remit, therefore is:

"To establish whether the design, build, commissioning and maintenance of the Queen Elizabeth University Hospital and Royal Hospital for Children has had an adverse impact on the risk of Healthcare Associated Infection and whether there is wider learning for NHS Scotland."

#### Review Team Established

In March 2019, Dr Andrew Fraser and Dr Brian Montgomery were appointed to undertake the Review as co-Chairs. They will be supported by Billy Hare, Professor of Construction Management at Glasgow Caledonian University and; Linda Dempster, the Head of Infection Prevention & Control for NHS England. A Review Team has also been appointed, to research, co-ordinate and manage the work of the Review.

Since taking up post, Drs Fraser and Montgomery have been exploring the key issues that may arise during the Review, assessing a range of documents relating to the topic, and holding informal discussions with key organisations and individuals who might aid the work. They have drawn up preliminary Terms of Reference for the Review, which sets out the intended scope of what the Review will cover. These can be accessed on the Review website
