1. Purpose of Paper

The purpose of this paper is to: inform the NHS Board on key items of discussion at the Inverclyde Integration Joint Board (IJB) which took place on 9 September 2024.

2. Recommendation

The Board is asked to note the key items of discussion at the recent meeting of the Inverclyde IJB on 9 September 2024 as set out below and seek further information or assurance as required.

3. Key Items of Discussion

- 3.1 The IJB noted the Period 3 Financial projection for 2024/25. This is showing a projected overspend of £0.495m which will be funded through the use of reserves if required. This is split £0.216m Social Care and £0.279m Health. The Board noted our current Capital and Reserves positions and approved the transfer of the remaining £0.479m from our transformation Board to our innovation fund. The Board also noted the progress made to date on the saving process where Inverclyde have achieved £1.898m of the £2.601m 24/25 target.
- 3.2 The IJB approved the new service manager for Homelessness and Settlement
- 3.3 The Board noted the appointment by Greater Glasgow and Clyde NHS of Ms Karen Turner and Dr Paul Ryan as voting members of the IJB. They also appointed Dr Rebecca Metcalfe to serve on the IJB Audit Committee.

- 3.4 The Chief Officer provided updates on the following ongoing activity:
1. Delayed Discharges, showing a continued reduction in discharges in Inverclyde.
 2. Review of Social Work Governance and Assurance in Scotland
 3. Connected 2 Care: Young Person-Led Conference.
- 3.5 The Board noted the new NHSGGC Primary Care Strategy and Implementation report 24/29.
- 3.6 The Board also Noted the Clinical and Care Governance Annual Report 23/24
- 3.7 The Board noted the 23/24 Annual Performance report and approved the new Strategic Partnership Plan Outcomes Framework. This new framework is aligned to the new Strategic Partnership Plan and it's performance will be monitored 6 monthly by the IJB and quarterly by the Strategic Planning Group.
- 3.8 The Board also noted the NHS GGC Mental Health Strategy refresh 23/28 and noted the community and partnership events taking place in Inverclyde in September 24. An event for staff will also take place in September 24.
