## 1. Purpose

The purpose of this paper is to provide an update on Board Members proposed allocation to Standing Committees and Integration Joint Boards (IJB) and seek Board approval.

## 2. Executive Summary

The following details describe the proposed Non-Executive Board membership of the Board's Standing Committees and the six local IJBs.

- Acknowledging the need for continuity through IJB Budget setting, Mr Frank Shennan stood down as a member of Renfrewshire IJB in March 2024. Ms Michelle Wailes assumed this role for the March and June 2024 IJB meetings on a temporary basis until new Board members are recruited for 1 July 2024. Mr Shennan stands down as a Board member at the end of May 2024. The Board is asked to approve this retrospectively. Appendix 1 notes this alteration to Board Member Responsibilities.
- The recruitment process is well underway to replace 6 Board members with interviews scheduled in the middle of May. Ahead of this, the Chair has reviewed Non-Executive responsibilities in terms of Chairs on the Board's Standing Committees and IJBs. The Board is asked to approve the following proposals effective from 1 July 2024:
  - Standing Committees of the Board:
    - Acute Services Committee (ASC) Mr David Gould to replace Mr Ian Ritchie as Chair.
    - Population Health and Wellbeing Committee Mr Charles Vincent to replace Rev John Mathews as Chair.

- The Chairing arrangements for the remaining Standing Committees are unchanged.
- Vice Chair roles are still to be confirmed.
- Integration Joint Boards:
  - Ms Ketki Miles to replace Ms Jacqueline Forbes as Non-Executive Lead and Vice Chair of East Dunbartonshire IJB.
  - Mr David Gould to replace Mr Alan Cowan as Non-Executive Lead and Vice Chair of Inverclyde IJB.
  - Ms Mehvish Ashraf to replace Ms Anne-Marie Monaghan as Non-Executive Lead and Chair of East Renfrewshire IJB.
  - Ms Margaret Kerr to replace Rev John Mathews as Non-Executive Lead and Vice Chair of Renfrewshire IJB.
  - Ms Michelle Wailes to replace Ms Rona Sweeney as Non-Executive Lead and Chair of West Dunbartonshire IJB.
  - The new NHS Board Vice Chair to replace Ms Rona Sweeney as Non-Executive Lead and Vice Chair of Glasgow City IJB.
- A further update will be brought to the Board in June making further proposals for Standing Committee and IJB membership, subsequent to the Non-Executive recruitment process.

In terms of overall Committee structure, it is proposed that an Equality, Diversity and Inclusion Committee is established. A full proposal will be brought to the Board in June 2024.
