1. Introduction

This paper is to provide an update to the Board on the overall position in respect of the NHS Greater Glasgow and Clyde (GGC) response to managing COVID-19. This paper is presented for awareness.

2. Epidemiology

COVID-19 in the community

The ONS Coronavirus (COVID-19) Infection Survey provided the estimated percentage of the Scottish community population that had COVID-19, based on a representative sample. After declining at the beginning of the year, to a low of 1.4% in the week to 24 January 2023, the community prevalence in Scotland started to increase again at the very end of January, rising to 2.4% by the end of February, with an oscillating plateau in the first two weeks of March (2% and 2.6% in the week to 6 March and 13 March respectively).

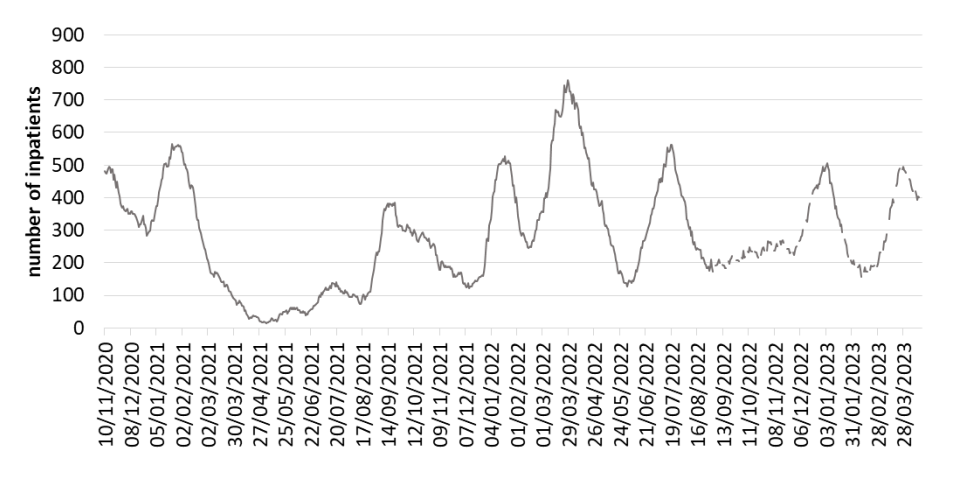
The ONS survey has now been discontinued, so that no more recent estimates of community prevalence are available. But inpatient data (see next section) showed that COVID-19 activity started to decline again over recent weeks.

Care homes continued to see COVID-19 cases amongst staff, reflective of ongoing community transmission. Outbreaks with symptomatic resident cases (largely mild symptoms), continued to occur in a small number of care homes (12 across NHSGGC as of 14 April 2023).

Inpatients with recently confirmed COVID-19

After the decline in the daily number of people with confirmed COVID-19 in hospitals in NHS GGC in January and February, numbers started to rise again steeply in March. In the latest wave, the daily number of people with confirmed COVID-19 in hospitals in NHS GGC peaked on 28 March 2023, at 494 inpatients (comparable to peak of 506 COVID-19 inpatients at the beginning of January 2023). Since then, the daily number of COVID-19 inpatients has started to decline again. As of 17 April 2023, there were 364 inpatients with recently confirmed COVID-19 in hospital in NHS GGC.

SARS-CoV-2 variants in Scotland

Omicron BQ.1 (a sub-lineage of BA.5) was the predominant variant in Scotland up until the middle of January 2023. In the weeks following, to the middle of February, there was no one dominant variant, with a number of Omicron sub-lineages co-circulating. By the most recent week for which sequencing data is available (week beginning 6 March 2023), the Omicron variant XBB.1.5 had become predominant.

3. Covid-19 Vaccinations

Autumn Winter 2022/23

The Autumn Winter campaign was completed on the 31st of March. 16 Clinics operated across the city with both booked appointments and drop in clinics being offered.

Attendance varied across the age cohorts for those with booked appointments within the vaccination clinics.

Staff Uptake

National Data in the table below shows staff immunisation uptake levels. Feedback across Scotland is that Staff vaccination uptake is reverting to pre – pandemic levels when the aim was for 50% of eligible staff to be vaccinated.

Spring Booster 2023

Spring Booster campaign officially started in the clinics on Tuesday 11th of April, however vaccination of Care Homes and Housebound residents will start on the 27th of March. The cohort of patients who have been invited are those aged 75 and over (or who will turn 75 by 30 June 2023), and anyone with a weakened immune system over the age of 5.

Using some of the key learnings from previous campaigns has allowed the service to look at the way the patients are invited. For the spring booster campaign our 75+ cohort will be invited up to 5pm and those aged 12 to 74 who are in the WIS category (Weakened Immune System) will be appointed from 5pm onwards.

The WIS cohort will be invited into our clinics from week commencing the 24th of April.

All of the clinics will be 10minute appointments.

The 5-11s who fall into the WIS category will be invited separately in the month of June.
