1. Purpose of Paper

The purpose of this paper is to: inform the NHS Board on key items of discussion at the East Dunbartonshire Integration Joint Board (IJB).

2. Recommendation

The Board is asked to note the key items of discussion at the most recent meeting of the IJB on 29th June 2023 as set out below, and seek further information or assurance as required.

3. Key Items of Discussion

- The Board approved the minutes of the meeting of 23rd March 2023.
- The Board received a verbal update from the Chief Officer which included an update on:-
 - Covid update - there is little community transmission or impact at present and no care homes in our area are experiencing a covid outbreak at present.
 - Continued significant pressures on NHS services including in-patient services. The HSCP continues to work to avoid unnecessary hospital admissions and facilitate timely discharges.

BOARD OFFICIAL

- A review of Primary Care Service provision for the population of Twechar and progress in completing a needs assessment in partnership with local residents and representative groups.
- Congratulations to Michelle Dalgarno, our Lead Advanced Nurse Practitioner, on winning the Leadership Award at the Royal College of Nursing Scotland's Nurse of the Year Awards.
- The Intensive and Unscheduled Child and Adolescent Mental Health Service Team from West Glasgow Ambulatory Care Hospital who were Highly Commended in the Nursing Team of the Year category.
- The Board began with a presentation, as part of the standing programme of Topic Specific Seminars, on the Care at Home Service, covering service demand profiles over recent years, covid response, the service delivery model, improvements and performance, staffing developments and challenges, and concluded by outlining the most recent Care Inspectorate inspection findings for the service which graded the service as Grade 5; Very Good; in all assessed areas. The Board then noted a report providing an update on a range of matters noted above and additionally focussed on the particular challenges over the period from November 2022 to March 2023. This experience informs local winter planning for the 2023 – 2024 period.
- The Board noted an update on the positive outcomes delivered following the opening of the new Allander Day Service for people with learning disabilities on the 9th March 2023.
- The Board received an update on the Property Strategy and delivery of accommodation requirements for East Dunbartonshire HSCP, noting the challenges in terms of premises available to deliver services within the HSCP particularly in the west of the area, which hamper delivery of strategic objectives and priorities such as PCIP.
- The Board approved the new East Dunbartonshire HSCP Carers Strategy 2023–2026 which had been developed following significant consultation and engagement.
- The Board noted and approved the proposal to update and extend the Alcohol and Drug Partnership locality strategy for 2023-25.
- The Board approved high level draft proposals for the delivery of the regional elements of the Scottish Government's Mental Health Recovery and Renewal (MHRR) Plan, phase 2 (child and adolescent services), for submission to the West of Scotland Regional Planning Group and noted proposals to progress an interim option for delivery of the regional adolescent IPCU.
- The Board considered and approved the publication of the HSCP Annual Performance Report 2022-23, that sets out progress towards the delivery of its Strategic Plan and the National Health & Wellbeing Outcomes.
- The Board considered and approved an update on the financial performance of the partnership as at month 12 (Year End) of 2022/23 and were presented with the Unaudited Accounts for 2022/23.
- The Board noted a report providing an update on the latest Primary Care Improvement Plan (PCIP) Financial Tracker, PCIP 6.
- The Board noted a report outlining how the Scottish Government's Children and Young People's Mental Health and Wellbeing Framework (CYPMHW) funding had been used locally to develop and support tier 1 and tier 2 mental health and wellbeing services. The Board noted the work is overseen by the Delivering for Children and Young People Partnership, which is a sub group of the East Dunbartonshire Community Planning Partnership.

- The Board noted a report advising members of the publication of the Joint Inspection of Services for Children at Risk of Harm Inspection Report, which highlighted many areas of good practice and effective partnership working and service delivery and resulted in an overall grade of 4; Good. The Board approved the related Action Plan for delivery, in as far as it related to actions required within delegated services. The Board noted that delivery of the overall action plan will be overseen by the Delivering for Children and Young People Partnership and will be discussed regularly with East Dunbartonshire's Care Inspectorate link Strategic Inspector.
- The Board approved an update to the HSCP Risk Management Policy and considered and approved an update of the Corporate Risk Register.
- The Board noted a report detailing the status of the Directions which are recorded and issued to East Dunbartonshire Council and NHS Greater Glasgow and Clyde Health Board by the Board, in line with the requirements of the Public Bodies (Joint Working) (Scotland) Act 2014.
- The Board noted the suite of minutes from the established governance groups, namely the, Performance Audit and Risk Committee, Clinical and Care Governance Group, the Strategic Planning Group, the Staff Partnership Forum, and the Public Service User and Carer Group (PSUC), including PSUC group members' reflections on attending the recent Healthcare Improvement Scotland on-line session on hospital discharge planning.
- The Board noted the proposed agenda items for future meetings.
