## **Patient Group Direction (PGD) for the supply of ciprofloxacin 500mg tablets for post-exposure prophylaxis to plague in adults and children 12 years and over**

This PGD is for the supply of ciprofloxacin 500mg tablets to adults and children aged 12 years and over exposed to a known or suspected deliberate release of plague (*Yersinia pestis*), by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

### **The UK Health Security Agency (UKHSA) has developed this PGD for local authorisation**

<b>Clinical condition or situation to which this PGD applies</b>	<p>Chemoprophylaxis following exposure to a known or suspected deliberate release of plague (<i>Yersinia pestis</i>)</p> <p><b>Notes:</b> no follow-on course for plague is required</p> <p>doxycycline is also indicated for post-exposure prophylaxis to plague. See <a href="#">doxycycline PGD</a></p> <p>Incident specific advice should be followed to support choice of antimicrobial</p> <p>For additional information on plague, including post-exposure prophylaxis, see <a href="#">CBRN guidance</a></p>
<b>Criteria for inclusion</b>	<p>Adults and children aged 12 years and over following exposure to a known or suspected deliberate release of plague (<i>Yersinia pestis</i>)</p> <p><b>And</b></p> <p>Are not showing symptoms compatible with plague infection. Individuals with symptoms should be referred urgently to the supervising doctor. See <a href="#">Action to be taken if individual or carer declines prophylaxis</a> section of this PGD and the <a href="#">CBRN incident guidance</a> for symptoms</p> <p><b>Note:</b> The benefits of using ciprofloxacin to prevent the onset of disease outweigh the potential risks of using this medicine in <b>growing adolescents, pregnant or breastfeeding individuals who should be given ciprofloxacin</b> in the situation criteria set out above</p>
<b>Criteria for exclusion<sup>2</sup></b>	<p>Individuals are excluded from this PGD if:</p> <ol style="list-style-type: none"> <li>1. They have a known history of severe allergic reaction to ciprofloxacin, other fluoroquinolones or quinolones or to any of the listed excipients (see <a href="#">SPC</a>)</li> <li>2. They are under 12 years of age</li> <li>3. They have had a previous known severe (disabling, life-threatening, incapacitating or requiring prolonged hospitalisation) adverse reaction to a quinolone or fluoroquinolone antibiotic</li> <li>4. They have a history of tendon disease/disorder related to ciprofloxacin or other fluoroquinolones or quinolones</li> <li>5. They are taking an interacting medicine as listed in the <a href="#">Drug interactions</a> section of this PGD</li> <li>6. They have known Chronic Kidney Disease (CKD) stages 4 or 5 (eGFR &lt; 30ml/min/1.73m<sup>2</sup>) or are on dialysis</li> <li>7. <p><b>Cautions including any relevant action to be taken</b></p> <p>(continued overleaf)</p>	<p>Caution is advised for individuals with the following conditions or who are taking certain medicines.</p> <p>Doxycycline is the preferred option for these individuals if it is not contraindicated and is available. See the <a href="#">Doxycycline supply PGD</a>.</p> <p>If doxycycline is contraindicated, or not available, then ciprofloxacin can be supplied as the benefit of taking it to prevent plague outweighs the risks. Individuals should be provided with the advice outlined below.</p> <p>Refer to the supervising doctor if concerned about an individual's risk for assessment and consideration of alternative antibiotics.</p> <p><b>1. At increased risk of tendinitis or tendon rupture:</b></p> <ul style="list-style-type: none"> <li>• over 60 years of age</li> <li>• have renal impairment (those with CKD stage 4 or 5 or on dialysis are excluded from this PGD)</li> <li>• are taking corticosteroids</li> <li>• have a solid organ transplant</li> </ul> <p>Advise to self-monitor for tendinitis (for example, painful swelling, inflammation). If signs of tendinitis occur, individuals should be advised to stop taking ciprofloxacin and contact their healthcare provider as soon as possible for assessment and consideration of an alternative antibiotic</p> <p><b>2. Conditions with risk factor for QT interval prolongation:</b></p> <ul style="list-style-type: none"> <li>• cardiac disease (for example, heart failure with reduced left ventricular ejection fraction, myocardial infarction, bradycardia)</li> <li>• congenital long QT syndrome</li> <li>• history of symptomatic arrhythmias</li> <li>• concomitant use of medicines known to prolong QT interval (for example, class IA and III anti-arrhythmics, tricyclic antidepressants, macrolides, antipsychotics)</li> <li>• electrolyte imbalance (for example, hypokalaemia, hypomagnesaemia)</li> </ul> <p>Advise to monitor for the exacerbation of or development of <a href="#">symptoms associated with QT prolongation</a>. Diabetes (especially if receiving treatment with oral hypoglycaemic agents or with insulin):</b> Disturbances in blood glucose can occur. Advise individuals to carefully monitor blood glucose during treatment, to be alert to symptoms of hypoglycaemia and hyperglycaemia and to seek medical advice if required</p> <p><b>6. G6PD deficiency:</b> There is a risk of haemolysis when ciprofloxacin is given to individuals with G6PD deficiency. If other antibiotics are not suitable and ciprofloxacin must be used, advise the individual to self-monitor for signs of haemolysis. If signs of haemolysis develop, advise individuals to stop taking ciprofloxacin and seek urgent medical advice</p> <p><b>7. Myasthenia gravis:</b> Advise to self-monitor for any increase in severity of myasthenia gravis. If an increase in severity of disease occurs, advise individuals to seek urgent medical advice</p> <p><b>Note:</b> doxycycline is also cautioned for individuals with myasthenia gravis.</p> <p><b>8. Severely immunocompromised individuals:</b> Individuals who are severely immunocompromised (as defined in <a href="#">Chapter 28a Green book</a>) should be advised to arrange an appointment with their GP or specialist before the end of the course to determine whether they need to continue treatment beyond the course outlined in this PGD</p> <p><b>9. Concomitant treatment with a vitamin K antagonist (for example, warfarin, phenindione and acenocoumarol):</b> Advise individual to arrange for INR to be monitored 3-5 days after starting treatment and to speak to their GP or anticoagulant clinic if they notice any signs of bleeding or unexplained/excessive bruising.</p> <p><b>Note:</b> INR also needs to be monitored with doxycycline</p>

Concomitant treatment with methotrexate, aminophylline, theophylline, erlotinib, ruxolitinib, phenytoin, fosphenytoin, ciclosporin or clozapine:</b> Advise individual to self-monitor for any signs of toxicity, and to contact the service responsible for monitoring these medicines as soon as possible to inform them of the treatment and to arrange appropriate follow up and monitoring  Refer to the <a href="#">SPC</a> for ciprofloxacin for full details on special warnings and precautions for use
<b>Action to be taken if the individual or carer declines prophylaxis</b>	Refer the individual to the supervising doctor  Advise the individual or their carer of the possible consequences of declining prophylaxis and of alternative options  Advise about the protective effects of the prophylaxis, risks of infection, and disease complications  Advise to seek urgent medical attention if they develop symptoms compatible with plague infection or <a href="#">signs or symptoms of sepsis</a> , Symptoms of pneumonic plague include: <ul style="list-style-type: none"> <li>• Fever, chills, sweats, headache, severe malaise, vomiting, diarrhoea, cough, increasing dyspnoea, watery sputum (may be bloody), associated chest pain</li> </ul> See <a href="#">CBRN guidance</a> for further information on symptoms of plague, including bubonic and septicaemic plague  Document the advice given and the decision reached

## 5. Description of treatment

<b>Name, strength and formulation of drug</b>	Ciprofloxacin 500mg tablets
<b>Legal category</b>	Prescription Only Medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>Yes: Ciprofloxacin is not licensed for use in plague. <a href="#">UK national guidance</a> recommends its use.</p> <p><b>Pregnancy</b></p> <p>The manufacturers advise as a precautionary measure to avoid the use of ciprofloxacin during pregnancy. However, the data available indicates no malformative or feto/neonatal toxicity but the <a href="#">SPC</a> does state that because of the effects of ciprofloxacin on immature cartilage observed in juvenile animals it cannot be excluded that the drug could cause damage to cartilage in the foetus. However, the benefits of using ciprofloxacin to prevent the onset of plague outweigh these potential risks in pregnancy. A patient information leaflet for ciprofloxacin in pregnancy is available here: <a href="#">bumps - best use of medicine in pregnancy (medicinesinpregnancy.org)</a></p> <p><b>Breastfeeding</b></p> <p>The manufacturers advice is to avoid breastfeeding during treatment with ciprofloxacin. However, quinolones are generally accepted for use during breastfeeding with caution. There have been concerns about adverse effects on infants “developing joints”, although this has only been reported in infants taking quinolone antibiotics directly. The calcium in breast milk may prevent or reduce infant absorption of quinolones. Use with caution in breast fed infants with known G6PD deficiency due to the risk of haemolysis and in breast fed infants with epilepsy.</p> <p>Ciprofloxacin may cause some babies to have mild stomach upsets and oral candidiasis.</p> <p>Where a product is recommended off-label consider, as part of the consent process, informing the individual/carer the product is being offered in accordance with national guidance but this is outside the product licence</p>
<b>Route / method of administration</b>	<p>Oral</p> <p>To be swallowed whole with water, as this will help to prevent the formation of tiny crystals in the urine (crystalluria), and preferably on an empty stomach</p>
<b>Dose and frequency of administration</b> (continued overleaf)	<p><b>Adults and children aged 12 years or over:</b></p> <p>One tablet (500mg) to be taken twice a day</p> <p>Administration should begin as soon as possible after suspected or confirmed exposure.</p>

<b>Dose and frequency of administration</b> (continued)	For individuals who are unable to swallow the tablets, refer to the supervising doctor for assessment and consideration of alternative antibiotics or formulation															
<b>Duration of treatment</b>	7 days															
<b>Quantity to be supplied</b>	<p>14 (fourteen) tablets</p> <p><b>Instruct the individual to take one tablet twice daily for 7 days only (that is 14 tablets in total) and to take the remaining tablets to a community pharmacy for disposal.</b></p> <p><b>Note:</b> No follow-on course for plague is required.</p> <p>When supplying under a PGD, this must be a complete over-labelled manufacturer's original pack or over-labelled pre-packs. The individual's name, the date and additional instructions must be written on the label at the time of supply. <b>As split manufacturers packs cannot be supplied, if an over-supply is required, individuals must be advised to take any remaining medicine to a community pharmacy for destruction.</b></p>															
<b>Storage</b>	Store in original container below 25 °C															
<b>Disposal</b>	Any unused product or waste material should be disposed of in accordance with local requirements.															
<b>Drug interactions</b> (continued overleaf)	<p>Concurrent medications should be checked for interactions. This list is not exhaustive. Full details of drug interactions are available in the <a href="#">SPC</a> and the <a href="#">BNF</a>.</p> <p><b><u>Excluded from PGD</u></b></p> <p>Where it is known an individual is concurrently taking one of the following medicines, ciprofloxacin should not be supplied under this PGD. If doxycycline is contraindicated (see <a href="#">doxycycline supply PGD</a>) refer individuals to the supervising doctor or other prescriber.</p> <ul style="list-style-type: none"><li>- agomelatine</li><li>- domperidone</li><li>- ergometrine, ergotamine or dihydroergotamine</li><li>- fezolinetant</li><li>- tizanidine</li></ul> <p>The following medicines may require dose adjustment. <b>Reporting procedure of adverse reactions</b>	<p>All suspected adverse reactions in children and severe adverse reactions in adults should be reported using the <a href="#">Yellow Card</a> system or search for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>Any serious adverse reaction to the drug should be documented in the individual's record and the individual's GP informed.</p>
<b>Written information to be given</b>	<p>Supply the marketing authorisation holder's Patient Information Leaflet (PIL).</p> <p>Consider providing the <a href="#">MHRA information leaflet</a> on side effects</p>
