1. Introduction

The Procurement Reform (Scotland) Act requires public sector contracting authorites with regulated procurement activity of £5 million or more per annum to have prepared a Procurement Stategy, and to publish an Annual Procurement Report each financial year. I am pleased to approve and publish the NHS Greater Glasgow and Clyde's report for financial year 2020/21.

This report covers a procurement spend for the period of £655m. There were 249 regulated procurements awarded in this period with an annual value of £77.5m (life time value of £230.7m), securing best value for Board spend, whilst obtaining financial and non-financial savings; through a commitment to maintaining high quality patient focused care by delivering sustainable and affordable clinical services with the capacity and capability to deliver modern healthcare with the flexibility to adapt to future requirements, through a positive approach to Fair Work and sustainability outcomes, including Community Benefits.

This report gives recognition of the impact that procurement policy and practice has on the Boards main objectives; Better Care, Better Health, Better Value, Better Workplace and can show the positive impact on performance and success.

In the light of the global outbreak of Covid-19 during this reporting period, the Board and the Procurement Team were put under severe pressure to continue to procure essential supplies, PPE and equipment to ensure the Board was able to effectively treat our patients and keep our staff safe. The support given to us by our National Procurement colleagues and the support from our Supply Chain was commendable. This was in truly exceptional circumstances and the team delivered this efficiently, effectively and I would thank them for their exceptional efforts during this time. Special acclamation must also be noted for our colleagues within Occupation Health, Health and Safety, Acute Services, Finance, the Health & Social Care Partnerships and the Army. The delivery of this service to the Board during this difficult time was truly collaboration at its best.

2. <u>Overview</u>

1.1 Purpose of this Report

NHS Greater Glasgow and Clyde (the Board) provides a comprehensive range of healthcare services to the population of Scotland. The Board purchases goods and services from a broad range of suppliers in support of these activities. As a Public Body this purchasing must be carried-out in accordance with the prevailing legislation including the Procurement Reform (Scotland) Act 2014 and the Public Contracts (Scotland) Regulations 2015.

These regulations require the Board to publish an Annual Procurement report covering content prescibed by the legislation. NHS GG&C financial year runs for the period 1/4/20 to 31/3/21. This report covers that period and is aligned to the Boards Annual Procurement Strategy.

1.2 Purchasing Strategy

NHS Greater Glasgow and Clyde (the Board) has an annual trade influenceable spend with third party suppliers of approximately £655m per annum. This expenditure is committed on behalf of the Board via the following five lead procuring departments.

These departments provide a comprehensive procurement and logistics service for all Health Board functions. This includes strategic sourcing and advice to improve effectiveness and value for money on all expenditure for goods, services and works. The departments have responsibility for purchase requirements for all Board areas including Corporate, Acute and Partnerships Divisions and operate within the context of the Board's published Procurement Strategy.

This Procurement Strategy sets out the basis for all procurement activity across GG&C. In summary this strategy continues to ensure GG&C's procurement service aligns with local and national strategies. It is intended to focus the procuring departments in delivering the highest level of service to End Users whilst delivering best value goods and services.

The strategy sets out clear, measurable objectives and priorities for improvement. Compliance and progress against these strategic objectives is reported quarterly to the Procurement Steering Group and annually to GG&C's CEO/Directors/Chief Officers meeting.

3. Procurement Highlights

<u>Covid 19</u>

The Coronavirus pandemic has had a huge impact on the National Health Service during 2020/21 and this has affected the Procurement Department greatly, putting unprecedented demands on the service. The service worked in partnership with NHSS National Procurement (NP), our colleagues and supply chain to ensure that all Personal Protective Equipment (PPE) and essential medical, clinical and facilities suppliers were available and suitable for use by all staff.

Shortages and delays in the supply of PPE were experienced in the early stages of the UK pandemic due to the demand on these goods world-wide. In response to this the Board established a PPE & Essential Supplies Group and Procurement were key to the work of the Group in terms of forecasting and reporting on stock levels to ensure that supplies were available to clinical areas.

The focus of the Department switched during the Pandemic and staff were transferred to temporary roles to deal with the new challenges. The decision by NP to restrict PPE resulted in bulk supplies being managed by the GGC Central Store. This required the need to establish a distribution network to deliver restricted PPE and emergency supplies to acute sites and to areas not previously delivered to: the newly set up Community Assessment Centres (CACs); Health & Social Care Partnership hubs; GPs; Opticians and Dentists. A store top-up service was also set up for each CAC thereby freeing up clinical staff to focus on patients and not ordering stock

The sourcing of PPE, and other items in short supply was also a key task of the department and staff were largely successful in identifying alternative suppliers and products.

Procurement Department

- Warpit Continual use of Warpit to share surplus items (furniture, equipment etc.)
- Commercial Team Procurement have achieved both financial, capital and cost containment savings during the period.
- Collaboration Successful collaboration of spend with other Public Sector organisation including our Health and Social Care Partnerships.
- General Data Protection Regulations Fully implemented into existing contract and now considered as part of all contractual arrangements.

- The Capital Programme for the Purchase of equipment was completed on time; making a total savings achieved during the period of approx £5.7m which was re-invested to purchase additional much needed equipment for patient care.
- NHSGG&C purchased 2 Da Vinci Robots which was part of a £20 million investment in 10 surgical robots across Scotland. Robotic Assisted Surgery results in less invasive procedures. This can reduce wound size and improve recovery times for patients.
- In July 2020 we commenced our pilot for the roll out of non-catalogue access with QEUH Theatres which has been very successful with positive feedback.

Benefits:

- Very easy to use
- Feels like one process rather than a series of steps
- Paperlite
- You can see the process of the order once approved
- Orders arriving quicker
- On average 1,000 paper indents / requisitions have been removed to date.

This programme continues to be rolled this out across Theatres within GG&C, HSCP's and various other acute sectors. Further catalogued items being considered will further reduce indents for white goods, furniture and stationary.

<u>eHealth</u>

eHealth have been working in collaboration with other Scottish Boards, National Procurement and CLO over the past few months to define and agree commercial principles and service levels to reduce costs and improve support services in relation to the introduction of a national Laboratory Information Management System Framework Contract.

Collaboration continues with National Procurement in relation to the upgrade of PACS system including the purchase of replacement of workstations.

eHealth are continuing to lead on a collaborative exercise considering West of Scotland Single System Working key applications and target operating model.

As part of the Board's response to Covid-19 eHealth purchased and installed additional hardware to facilitate the move from physical to virtual clinical consultations and staff remote working whilst dealing with major supply constraints due to world-wide component shortages.

Financial savings and cost containment have been achieved during the period in relation to the purchase of IT equipment, services and maintenance contracts.

Medical Physics

As part of NHS GG&C capital medical equipment replacement programme, in 2019-20 we purchased new medical equipment across the Health Board area. As a result of this investment it allowed us, during 2020, to donate the following equipment we had replaced, to charity:

25 x Defibrillators12 x Suction Units8 x Anaesthetic Machines with associated patient monitoring

This equipment was donated to three charities, Project Gambia, African Scottish Development Organisation and Scotland na Kenya. The equipment was transferred to hospitals in Africa. Photo from Project Gambia below:



Capital Planning

In 2020/21 the Board opened two new mental health wards at Stobhill and took possession of the new Greenock Health & Care Centre. The Stobhill project achieved a BREEAM Excellent rating and Greenock on target to receive a Very Good rating, which was agreed with Health Facilities Scotland. Extensive use was made of supported business RSBi in the fit-out of these projects. Design work has been carried out and the first stage of enabling works undertaken for North East hub. This is the first facility that the board has taken forward which is designed to achieve zero carbon in operation. Alongside these a continuing series of upgrade projects were completed including HEI upgrades at Ward 64 and MRI replacement at the Institute of Neurosciences, GRI Theatre upgrades, Pedestrian walkways at QEUH and various diagnostic replacement schemes.

Operational Estates

Operational estates service and maintain the plant and equipment which support the day to day operational use of all healthcare facilities (be that an acute hospital or a health centre). To carry out servicing & maintenance of this equipment there is a need to employ specialist contractors on service & maintenance contracts.

Procurement have worked closely with operational estates to deliver contracts to support the following contracts (to name a few);

- Lift servicing & maintenance;
- Firefighting equipment maintenance;
- Fire Alarm servicing & maintenance;
- Boiler servicing & maintenance;
- Water systems compliance and maintenance

Corporate Estates

Corporate estates covers the following areas;

Statutory Compliance; Energy; Sustainability & Minor Projects;

A number of frameworks have been created to support these areas of work especially within the 'minor projects' area of work. These include frameworks to support;

- Asbestos surveying & removal;
- electrical contractors;
- Engineering Professional Services.

There were a large number of 'minor projects' delivered during the year (circa 150) with the support of the procurement department. These project had a total spend in the region of £10m annually. These projects support the 'life cycle replacement' of strategic operational assets across the whole healthcare estate (ie ventilation, heating & lighting systems).

<u>Transport</u>

To ensure a reduction in the C02 reductions, the Board continue to procure electric vehicles.

Pharmacy

A number of innovative developments have taken place across pharmacy in the past 12months despite the pressures associated with the pandemic. The Pharmacy Distribution Centre introduced an 10th robot, this time being build and commissioned inside one of the existing cold rooms. This enables a quicker and more accurate pick and increases the volumes of items being picked automatically to 80%. This installation is the first of its kind in the UK and ensured on-going service provision despite reduced workforce during the pandemic.

PDC, Quality Assurance and Transport teams have worked collaboratively to develop a tender specification with procurement colleagues which has enabled the introduction of a bespoke transport fleet at the PDC. The 3 chamber vehicles satisfy new Medicines Health Regulatory Authority GDP legislation for transportation of ambient, refrigerated and CD lines.

Unit C is an extension to the main PDC footprint and houses the re-located vaccine holding centre which opened in Mar 21. The state of the art premise is the central hub for all vaccine supplies across NHSGGC and Argyll & Bute and has created capacity within the main department to store some bulk stock of critical lines used to treat covid positive patients within the acute setting.

Pharmacy has played a key role in the business case and procurement of the hospital electronic prescribing and medicines administration system (HEPMA) which delivers safer and more efficient prescribing and administration of medicines as taking as toward the aspiration of a single electronic patient record across all health sectors. Implementation is well under way and is expected to be completed during late 2022.

4. Summary of Regulated Procurements Completed

The Board has awarded 249 regulated procurements with a combined an annual value of \pounds 77.5m (life time value of \pounds 230.7m) during the period 1st April 2020 – 31st March 2021.

5. Review of Regulated Procurement Compliance

The Procurement Strategy is valid for the period to 31/3/22. The Procurement Steering Group provides an oversight of Procurement activities within the Board and this steering group meets quarterly, however due to the Coronavirus Pandemic, this group did not meet during the reporting period. However, Procuring departments establish annual operational plans to deliver the strategy with compliance reports on the operational plan progress presented regularly to the Steering Group to evidence compliance to the Procurement Strategy.

6. Community Benefit Summary

The Board has adopted a process to ensure that every contract provides the opportunity to develop and encourage the market to consider the economic, social, and environmental wellbeing of the authority's area. Community Benefits are included and information is sought from suppliers as to what benefits they may be able to offer, on a non scoring basis.

This approach is underpinned by the Board's Better Health Through Employment Strategy. This strategy supports the aim to consider what action departments can take to help people get in to work, stay in work and improve their health through work. Employment related Community Benefit clauses in public contracts allows the Board to support this objective by seeking Community Benefits within its specifications for works, goods and services.

To further develop our commitment to community benefits, we now include community benefits as a condition in all contracts over the regulated procurement threshold.

Tracking delivery of newly awarded CBC's is now achieved via contract management procedures between procurement and the suppliers. The contracts with community benefits gained are included in Appendix 1. Significant progress has been made in our construction contracts during this reporting period which include community benefits in all projects over £4m, a summary of the community benefits gained in construction contracts is detailed in appendix 2a, 2b, 2c, 2d and 2e.

7. Supported Business Summary

The Board continues to seek opportunities to use Supported Businesses where practical.

Spend with Supported Business in this reporting period is lower than in previous years due to the impact of the Covid-19.

At Contract Strategy development stage consideration is given to the potential participation of a Supported Business to deliver the contract. If a Supported Business has the potential to deliver the contract, this is considered within the strategy.

We have developed close working relationships and have developed new services in partnership. Specific examples include:

- Refurbishment of used furniture for reuse
- Recovering of equipment used within acute sites
- Pre-planned purchase of office furniture to allow improved production co-ordination
- Purchase of 'office of tomorrow' furniture for new build offices
- Supply of any new pedestals purchased
- IT Disposal and resale

GGC continue to attend 'Meet the Buyer' events, to meet with supported business, SME's and other organisations. This assists with allowing the supply chain to understand how we procure goods and services for the organisation. Principal Supply Chain Partners providing Capital Projects also hold "meet the buyer" events and take actions to engage with local SME's. These are recorded as part of the community benefits tracking.

8. Future Regulated Procurements Summary

Section 18(2) of the Procurement Reform (Scotland) Act 2014 states it is mandatory that an annual procurement report must include "a summary of the regulated procurements the authority expects to commence in the next two financial years." This is shown in the attached Appendix 3.

9. Delivering Value for Money

9.1 Contract Savings

Working with Clinical colleagues the Procurement Department has a critical role in supporting the delivery of the Clinical Services aims, specifically in procuring the best quality, and value for money goods and services to ensure patients receives the highest standard of care. £648,843 of recurring and non-recurring savings was achieved in the reporting period by price reduction across goods and services purchased by wards and departments.

9.2 Capital Equipment Purchase

The Board replaces higher value medical equipment via its capital expenditure allocation. The Procurement Department works closely with clinical colleagues to ensure the maximum value is obtained against the budget allowance. Savings achieved during the period of approx £5.7m

achieved by reducing the cost of purchase are re-invested into additional equipment essential for patient care.

10. Sustainable Procurement Duty

The Procurement Reform (Scotland) Act 2014 requires authorities to comply with the sustainable procurement duty where applicable. This includes a requirement to support Small and Medium Enterprise (SME), Third Sector Bodies and Supported Business organisations gaining public contracts. The Board seeks to ensure that we meet this duty by adopting the Scottish Governments Procurement Journey methodology and use of contract strategy templates.

During this reporting period the Board has implemented the following specific initiatives:

- a) **Promotion of Innovation** Procurement Officers must consider ways of promoting innovation in all regulated procurements, examples may include whether allowing a variant solution for all or part of the requirement would be in the best interests to the Board.
- b) Sustainability Toolkit To assist with the segmentation of our supply base, the Scottish Governments Sustainability Toolkit has been used to identify our top risk, key suppliers to ensure contract and supplier management is taking place with our key suppliers.
- c) WARPit The Board have worked with WARPit to incorporate this ethos within our Board and all staff can access it via our Internal Web page. This portal makes it easy for Board staff to share surplus items (furniture, equipment etc.) with other individuals. Many unwanted items are often put to waste; however, WARPit makes transfer of ownership quick and easy due to better communication.

WARPit will help limit the amount of waste the Board sends to landfill and reduce both our disposal costs and our carbon footprint. Re-using furniture and office supplies saves money spent on purchasing new equipment and helps to free-up the space occupied by unused equipment. Each transaction is monitored and every participant is registered, which means that waste disposal obligations and legal liability concerns are met. The portal also provides detailed up-to-date information on both the environmental benefits and financial savings generated."

This has been very successful allowing the Board to not only make a Cost Avoidance saving of £268,742 but has reduced the number of items sent to landfill. The process includes working with Scottish SMEs, Support Business refurbish furniture where required.

d) Procurement Contract Awards

An award of a contract for Laundry Dosing Equipment and Chemicals has given a press efficiency to optimise and remove the over usage of energy for drying and excessive potential over usage of water and energy.

The Courier Services contract award aligned with the Government's Cleaner Air for Scotland strategy. Driver training to coach the team on safe, fuel-efficient driving, focussing on correct usage of gears, no idling or over-revving etc. Couriers vehicles are <36 months old, meaning the cleanest engines available, utilising PHEV electric vans. Software is used to ensure the allocation of the most appropriate driver to a collection before directing him or her to take the most efficient route, A to B. The supplier supports their commitment to achieve EcoStars Fleet Recognition Scheme 5* under the EcoStars Recognition Scheme.

NHS GGC currently generate in the region of 30,000 bags of confidential waste per annum. NHS GGC confidential waste paper received by the supplier and is sold onto a paper mill providing a saving whilst generating a rebate for NHS GGC and ensures the confidential waste paper is recycled instead of ending up on landfill.

e) Sustainable Procurement Working Group

Due to the pressures of the Coronavirus, this group did not meet or take forward any projects in 2020/21. It will recommence in 2021/22.

f) Circular Economy

WARPit will help limit the amount of waste the Board sends to landfill and reduce both our disposal costs and our carbon footprint. Re-using furniture and office supplies saves money spent on purchasing new equipment and helps to free-up the space occupied by unused equipment. Each transaction is monitored and every participant is registered, which means that waste disposal obligations and legal liability concerns are met. The portal also provides detailed up-to-date information on both the environmental benefits and financial savings generated."

This has been very successful allowing the Board to not only make a Cost Avoidance saving of £256,448 but has reduced the number of items sent to landfill. The process includes working with Scottish SMEs, Support Business refurbish furniture where required.

Although NHS GGC's Warpit figures are good compared to other Boards. Further savings could be utilised by promoting extensively across the Board and having more internal resource to manage this system to re-use and upcycle materials.

g) Capital Planning

The hub projects set a high bar when considering the incorporation of sustainable measures. This is achieved by setting a requirement that the projects achieve BREEAM Excellent. A reduced rating may be agreed with Health Facilities Scotland,

through the NDAP process, where a project is recognised as requiring additional measures to achieve Excellent that would not be assessed as good value for money.

BREEAM is a sustainability assessment method for planning projects, infrastructure and buildings to ensure a higher performing assets across the built environment lifecycle. BREEAM does this through third party certification of the assessment of the environmental, social and economic sustainability performance, using standards developed by BRE (Building Research Establishment). This means BREEAM rated developments are more sustainable environments that enhance the well-being of the people who live and work in them, thus protecting natural resources.

We would specifically highlight the following key points across the life of the building:-

Design phase

- Designed to accommodate adaption over the life of the building.
- Designed where possible for multi-functional use.
- Designed to support alternative modes of transport.
- Designed to support different working styles, including agile working, all in a quality working environment.
- Specify a range of low carbon technologies where appropriate including, district heating, photovoltaic and air source heat pumps.
 - Specify systems that allow GG&C to monitor energy and water use over the life of the building.
 - Agreed waste streaming facilities accommodated in the design.
 - Monitor the use of sustainable and recyclable materials.
 - FM provider involved through out to ensure that building can be suitably maintained and that materials are selected accordingly

Construction Phase

- Set high targets for the reduction and management of construction waste.
- Set targets for the management of traffic miles associated with the project.

Operational phase

- Green travel plan developed to support staff using the building.
- Energy and water use monitored and reported at monthly intervals.

h) Transport

This year has seen the growth of our success in increasing our Electric Vehicles which has been supported by switched on Fleet funding and the growth of our charging infrastructure which we have had supported by the same funding stream.

Planned for the next year is to procure training services for driver training and to review the charging infrastructure for Electric vehicles.













SUPPLIER NUMBERS AND SPEND GRAPH;

TRAINING


To ensure we measure success against our ISO9001:2015 and ISO45001:2018 Objectives we carry out internal training for all staff and employees. The Courses and Certification details are contained on a training Matrix for all our staff and employees, which highlights, what qualifications that person has attained, relevant refresher courses dates and planned training needs for the coming year. This is integrated with our Training Policy and Operational Training Procedure OP11. We review our training needs at the Quarterly Management meeting. We are able to carry out a lot of the training "in house" through our qualified Operations Director Graham Hancock, who is a qualified TWI Instructor (Training within Industry).

Any training needs we are unable to carry out "in-house", we will out-source to the appropriate qualified training instructor and training body.

As part of our Training plan we also have the minimum qualifications our staff require, which are set down as Mandatory and Future Needs. As part of the objectives we have the following mandatory training:

- Minimum 2 toolbox talks of 30minutes per month
- Minimum training 2days training per year per employee
- Further training from any legislation changes
- 20min Infection Control DVD for all MPMH employees, Partnering Contractors that will be working on the site. This will be carried out at the Site Induction.

EMPLOYMENT AND SKILLS PLAN TRAINING SCHEMES

MPMH are a local company located in Glasgow, where we currently employ 13 Professional staff and 47 directly employed tradesmen. These staff and trades people have been used in the existing NHS framework and previous NHS Hospital projects, for NHS Greater Glasgow & Clyde, NHS Lothian, NHS Highlands, NHS Ayrshire & Arran, NHS Tayside, National Services Scotland and NHS Lanarkshire.

Over the last 7 years we have employed 6 apprentice trades people from the Lanarkshire area and 5 from the local Glasgow Area who have all worked on our NHS GGC projects. As part of the Framework we have also provided training and enhanced the skills for recruitment of semi-skilled labour where we have employed 14 people over the last 6 years, which has increased their career opportunties.

We have also taken on one full time administrator through the back to work scheme and in November 2019 we started a new Graduate Quantity Surveyor from Glasgow, who is now working on the Queen Elizabeth University Ward 2A project. Over the last 4 years we have provided a total of 3 weeks work experience for to Local Secondary schools.





COMMUNITY ENGAGEMENT

We have used our supplier agreements successfully for our NHS Greater Glasgow & Clyde projects, where we have successfully involved the local community in each of the Greater Glasgow regions. We have highlighted the use of local SME suppliers and sub-contractors in the previous graphs and we continue to implement the same process for any proposed new NHS Greater Glasgow & Clyde projects.

CHARITIES

For the last 5 years MPMH have been assisting the NHS Greater Glasgow & Clyde Capital Planning with their annual MacMillan Cancer Charity Coffee morning, by providing home baking, donations and raffle prizes and further assistance by providing resources and time to help the NHS generate monies for a very good cause. We have allocated 2 members of staff for the day on every occasion including donations, sponsorship and staff time to prepare the home baking.

Through NHS National Services Scotland we have worked with Scotland's Bravest. Scotland's Bravest are Armed Forces Veterans with injuries or disabilities who are adjusting to life outside of the military. They manufacture signs, panels and digital prints at Erskine Hospital. MPMH have assisted by providing some Health & Safety Training through our External Health & Safety Consultant to assist their needs. They have also provided signage for MPMH at various NHS projects and most recently at the Macmillan cancer ward in Oban and the Inverclyde Royal Hospital External signs.








ENVIRONMENTAL COMMITMENT

We seek to develop local supply chains, if they are economically and environmentally viable to the specific project, MPMH also promotes the use of renewable materials such as sustainable timber and building products. We are also developing the use of other recycled products within our deliverables. We are currently achieving 100% for all our site waste recycling. In 2018 we generated 426 tonnes and in 2019 we generated 312 tonnes of waste, which 92% was re-cycled and the remaining 8% was recycled through RDF. In 2020 we have reduced our site waste generated to 307 tonnes with 96% of mixed waste being recycled with remaing 4% recycled through RDF, which enabled us to achieve 100% waste recycled. Our Company now use design and construction methods that minimise adverse effects on the environment, by reducing and minimising energy consumption and related Co2 production. By careful selection of materials used, we look to minimise the amount of waste created during the design, construction and lifetime of the building.



Project: North East Hub

This report aims to provide an update on the social value plan and delivery for the North East Hub project and will be issued on a quarterly basis.

Overview

A community investment group has been set up to help develop the social value plan for the North East Hub project. The priority groups are at the core of the plan and delivery and these have been identified as:

- 1. Care experienced individuals
- 2. Rehabilitating offenders and people recovering from addictions
- 3. Pupils from Whitehill and St Andrews Secondary Schools

Other care groups will be supported and benefit from the project including the local community and the project workforce but the above groups are a core focus and the work we carry out will be tailored at supporting them.

In order to support the priority groups and meet the aims and targets of the project, we are developing and delivering the following programmes:

- 1. **Education Programme**: A work based learning programme for pupil's developed with Glasgow Kelvin College and Skills Development Scotland.
- 2. **Construction Work Academy**: A work academy to support rehabilitating offenders and people with addictions back into employment.
- 3. **Wellbeing Programme**: Working with the NHS to support the health and wellbeing of the staff working across the project.
- 4. **Community & Volunteering Programme**: Supporting the local community and delivering hWS's Helping Hands Project.
- 5. **SME Development Programme**: Ensuring the local business community are supported and gain access to opportunities across the project.

Please refer to *annex 1* for a summary of the process and programmes.

The work we are doing with education support with the college and the programmed aimed at the rehabilitating young offenders and recovering from addictions during the design development period will enable these groups to get 'work ready' and available for work trials, meaningful work placements and **sustainable employment opportunities** once the project is on site. We will be working closely with the supply chain to set out commitments for these areas. We are working with Jobs & Business Glasgow as the employability partner and all opportunities will go through them to be made available to local people. We are working with a range of local providers and aim to provide as many opportunities as possible for the local business community and we are actively seeking to identify local SMEs & Third Sector Organisations.

The project will be reported on the **Social Value Portal** on SFT's TOMs (Themes, Outcomes and Measurements). The portal focuses on the following key themes which our programmes and activities directly feed into:

- 1. Fair work
- 2. Entrepreneurial, inclusive and sustainable economy
- 3. Inclusive, empowered, resilient communities
- 4. Protecting & enhancing the environment
- 5. Social innovation

The portal will allow us to report on the Social & Local Economic Value (SLEV) added by the project and our activities.





Community Benefits

BAM Construction: Third Sector Organisation Engagement

Project: Greenock Health Centre **Organisation:** In Works Enterprises (Social Enterprise) **Overview of engagement**:

In Works Enterprises are a local Social Enterprise based close to the Greenock Health Centre site. In Works provide landscaping, grounds maintenance, planting, and community projects across Glasgow and Clyde, Inverclyde and Renfrewshire areas. We engaged In Works in the following ways:

- Work Experience placements: Work placements were offered to candidates supported by In Works and two people were put forward for Hard Landscaping experience on site. Training opportunities were also offered via our training partner AVQ Management.
- **Donation & transportation of a cabin:** The project team arranged for the donation and transportation of a portacabin for use at In Works site but unfortunately due to site restrictions In Works were unable to take and keep the cabin.
- Creation of outdoor space: Due to Covid-19, the project team required more space for staff use and to implement safe social distancing and so they engaged In Works and made use of their hall and community space. The M&E contractor used the space as their base and in return BAM donated materials and helped to create an outdoor seating area, purchasing tables and chairs for future use. A full time cleaning position was supported through out and they cleaned the space and surrounding areas on a regular basis. This engagement also led to increase spend and support in In Works' café with the workforce using it for food and drinks throughout their working days.

Overall the engagement was great and both the BAM project team, wider workforce and In Works have been able to support each other during the construction phase. Around £5,500 has been invested between staff time and in kind donations.

Project(s): Greenock Health Centre & Clydebank Health & Care Centre Organisation: Community Wood Recycling (Social Enterprise) Overview:

Community Wood Recycling are a network of wood recycling social enterprises providing an efficient and cost effective collection service for waste wood. Their main aims are to:

- Save resources by reusing and recycling waste timber
- Create jobs, training and volunteering opportunities for disadvantaged people

As well as providing onsite recycling needs, Community Wood provides opportunities for a wide range of disadvantaged people, helping with training, volunteering opportunities and onto employment. They help a range of people including ex-offenders, those with mild mental health or learning difficulties and people who have come through drug and alcohol abuse.

Through the Greenock Health Centre and Clydebank Health & Care Centre projects, we engaged with Glasgow Wood Recycling (who are based close by to the Clydebank site) for onsite wood recycling needs.

Glasgow Wood also create bespoke furniture from reclaimed wood and we engaged them to price benches and a memorial plaque at Greenock.

We have started working with Community Wood Recycling at a national level within BAM, utilising their local social enterprises and in 2020, we spent over £16,000 across a range of projects.

Project: North East Hub **Organisation:** Royal Strathclyde Blindcraft Industries (RSBi) (Social Enterprise) **Overview:**

We have not yet began the mains works on site or started to work with any third sector organisations but have been in engagement with RSBi and they will be pricing works on the project.

Royal Strathclyde Blindcraft Industries (RSBi) specialise in manufacturing a wide range of products and are dedicated to making a difference in the community. They provide a range of opportunities for people with disabilities, as well as helping towards the economic regeneration of the local community and beyond.

We have recently worked with RSBi on other projects in Scotland and awarded work packages worth over £150,000.

Other

In regards to other third sector engagement and support, The Men's Shed Association are a registered charity and we engaged with and supported the following local sheds:

Stobhill Mental Health Units: Working with Springburn Park's Men's shed, the project and supply chain donated materials and cabins. They fitted out the cabins so they could be used for a range of purposes for the men's shed and the wider local community. A memorial was also created and placed in the legacy garden of the project for a late member of the Men's shed. The level of engagement and support was amazing and over £16,000 was invested between staff time and in kind donations.

Greenock Health Centre: Invercive Shed created a memorial plaque (free of charge) for a late local nurse to be placed on site as part of a legacy project. The engagement was excellent and the shed couldn't have been more helpful. A news story will be run on the plaque and we will highlight the sheds engagement, contribution and services.

Clydebank Health & Care Centre and North East Hub: We are hoping to engage both the local sheds across these projects but due to the current situation, they are both closed. We have spoken to them and made them aware we would like to engage and support in any way we can and we will look at ways to support through resources and donations of materials once they reopen.
